What is the overall <u>deductible</u> ?	\$750 individual/\$1,500 family <u>network</u> . \$1,500 individual/\$3,000 family out-of- <u>network</u> .	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your <u>deductible</u> ?	Yes. Office visits, preventive care services, emergency room care, urgent care, rehabilitation services, and prescription drug benefits are covered before you meet your network deductible.  Copayments and coinsurance amounts don't count toward the network deductible.	This <u>plan</u> covers some items and services even if you haven't yet met the <u>deductible</u> amount. ### Does this <u>plan</u> provide <u>Minimum Essential Coverage</u>? Yes

If you are eligible for certain types of Minimum Essential Coverage, you may not be eligible for the premium tax credit.
